What is my role as a parent/guardian?

Please be prepared to participate in the initial assessment at the JARF and assist in planning steps for further recovery or extended services as needed.

Is this service confidential?

We understand the importance of your family's privacy. Any information shared with our counselors and staff is confidential, to the extent allowed by the law.

How much does treatment cost?

The cost of your child's treatment depends on his or her individual need. We have a number of funding options available, including private insurance, and a sliding-fee scale based on income. We will assist you in finding the most cost-effective method of payment for you and your family.

What does my child need during his or her stay at the JARF?

Please bring your child's social security card, proof of insurance and/or income and any prescription medications he or she is currently taking.

JUVENILE ADDICTIONS RECEIVING FACILITY (JARF)

The Juvenile Addictions Receiving Facility (JARF) provides a safe environment for evaluation of an adolescent experiencing a substance abuse crisis. The JARF is a secure, medically supervised facility providing inpatient assessment, detoxification, stabilization, short-term (3-5 days) treatment and referral services for adolescents, ages 12-17. The program provides 24 hour, 7 day a week services for voluntary or involuntarily admitted clients. Involuntary clients must meet Marchman Act* criteria and can be admitted directly by a parent/guardian, law enforcement, physician's certificate or court order.

Services Provided:

Comprehensive Assessment	Recommendation and Referral

Once admitted into this program, the adolescent will be examined and evaluated by a psychiatrist or other qualified medical staff to determine the level of treatment needed to provide the necessary steps for recovery.

Plans for continuing care begin once an assessment is complete. At the time of discharge, referrals and recommendations for ongoing treatment will be provided. A recommendation for extended services may be made to ensure a successful recovery. In this situation, the **Compass Center**, a residential treatment program for adolescents, may be the appropriate environment for care.



WE CAN HELP

The Compass Center provides residential treatment for adolescents, ages 13 to 17. We provide supervised programs and treatment services, 24 hours a day, seven days a week. Admission is voluntary. The average length of stay is six months.
